Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

T1 - Rowan - Fell to near ground level

Reason: multi-stemmed tree with inherently weak included bark unions. Recently failed stem has soft pulpy decay, mycelium between bark and wood, with rhizomorphs visible within soil, all indicating infection with Honey Fungus (*Armillaria* sp.). Upper crown of remaining stems with dieback and live crown more sparse than would be expected for a healthy specimen indicating root dysfunction, likely a result of Honey fungus infection. Further failure is likely so removal is required.

Replacement: Silk Tree (*Albizia* sp.)

T2 - Ash - Pollard young growth back to near previous cuts retaining pollard knuckles

Reason: as part of good arboricultural practice to continue the cyclical management of the tree

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - mark and name surrounding roads
 - sketch in buildings, including adjoining properties
 - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
