T1 - Rowan - Fell to near ground level
Reason: multi-stemmed tree with inherently weak included bark unions. Recently failed stem has soft pulpy decay, mycelium between bark
and wood, with rhizomorphs visible within soil, all indicating infection with Honey Fungus (Armillaria sp.). Upper crown of remaining stems with dieback and live crown more sparse than would be expected for a healthy specimen indicating root dysfunction, likely a result of Honey
fungus infection. Further failure is likely so removal is required.
Replacement: Silk Tree (Albizia sp.)
T2 - Ash - Pollard young growth back to near previous cuts retaining pollard knuckles Reason: as part of good arboricultural practice to continue the cyclical management of the tree
