Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

The tree is located in the front garden of the property. It is of a coniferous type and appears to be in good health. The proposal is to top the tree so that its height is not greater than its distance from Maley Cottage. This work is being proposed on the recommendation of a structural survey which identified the best and safest height for any tree adjacent to the property. Maley Cottage is grade II listed and was built around 1800 and has only limited foundations, rendering it susceptible to subsidence from the disturbance caused by things such as tree roots. The part of the cottage nearest to the tree has undergone historic subsidence.

The works will be carried out at a time when birds are not nesting. The waste materials from the topping will be processed on-site and sent for composting.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
