Scotts Pine (T1) - Remove - leave as high stump, top of tree has ripped out. Tree has suppressed canopy due to adjacent pine trees. Once rip out is removed - little significant canopy remaining.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
