(T1) Oak: Reduce North side and top by 2 to 3 metres, and south side by 3 to 4 metres to balance the tree. Current height is 11 metres after reduction will be 9 metres, Current spread is 14 metres after reduction will 9 metres. Reason for works is excessive shading and to balance the tree.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - o showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
