T1. Sycamore. Crown thin by removing growth from the interior of the crown and out to the periphery of the crown in order to lessen the foliage density by 15%.

This work is in order to allow increased light levels to the garden beneath and thereby improve the owners use and enjoyment of the garden without compromising the overall stature, form and amenity value of the tree.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - $\circ\,$ showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
