# Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

T1 - Scots Pine - Unusual form having lost its central leader in the past. It now consists of several etiolated branches. Most of those branches are subsiding due to their unusual formation. They are highly prone to breakage. The presence of the tree is compromising the development of the adjoining oak. It would be prudent to replace the tree with a better specimen that would not have the propensity to failure that this tree does. Action: Remove.

T2 - Ailanthus - Typical broad spreading form. The main union between stems at circa 1.8m above ground level has suffered primary failure. One section that overhangs the adjoining drive way and public park is highly vulnerable to collapse. The retention of the tree is unviable and it should be removed. Its removal will enable the development of the adjoining sycamore and oak trees within the adjoining public park. Action: Remove.

T3 - Sycamore - Suppressed by the adjoining ailanthus. Removal of the ailanthus, due to its significant defect, will enable this tree to develop. Action: No action.

T4 - Goat willow - Smaller tree that is smothered in ivy. The tree is lacking vitality and is sparsely foliated. I recommend that the ivy is removed and the crown is slightly reduced in size to promote a flush of new growth. The tree is currently circa 9m in height. A reduction to 7m in height would be prudent. Action: Reduce crown to 7m in height. Prune lateral branches to suit. Cut ivy at base and allow to die. Remove basal shoots.

New Tree Planting - As part of the redevelopment of the property a new landscape scheme is being prepared to in-corporate substantial new planting that will provide replacements for those trees being removed and supplement the tree cover in the village.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
