Maturing silver birch - bottom LHS of garden. TPO 12782. Reduce and shape approx 4 meters to take back to height when previously reduced 5 years ago, due to excessive growth. Leaving a final height of 7-8 meters with a raduis of 2 metres. Thin crown density by approx 15%.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
