Identification of Tree(s) and Description of Works
Please identify the tree(s) and provide a full and clear specification of the works you want to carry out
A plum tree planted around twenty years ago by the previous occupant is located at the western border of the property, i.e. at the top of the back garden and adjacent to a communal access footpath serving this property and the neighbouring property (Church View, 6 Court Farm). The tree also sits adjacent to the boundary of 6 Court Farm.
There is work ongoing jointly with 6 Court Farm to remove and replace fencing and provide suitable access to the garden.  Other than through the house - which is in the middle of a terrace of three homes - sole access to the garden is via the communal rear path.  Access into the garden and subsequent location of a new gate are compromised by the position of the tree.

Current work is being carried out by Longwoods Fencing and Gardening Services of Midsomer Norton who have informed the applicant that there is evidence that roots from the tree are extending through the applicants garden causing disruption to the ground. Evidence would suggest, therefore, that the neighbouring property could also be affected by root extension. The householders at 6 Court Farm, Mr and Mrs Lewis, have informed the applicant of their support for the removal of the tree.

It is proposed to remove this plum tree to below ground level, to then remove the root system if practicable, or cover over to restrict or extinguish further growth of the tree.

Longwoods are on site at the time of application and are prepared to carry out the works that are being requested.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

  - o mark and name surrounding roads

  - o add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - o marking all trees on the plan, but only numbering those to which you want to carry out work
  - showing the approximate distance between the application tree(s) and buildings
  - o adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
