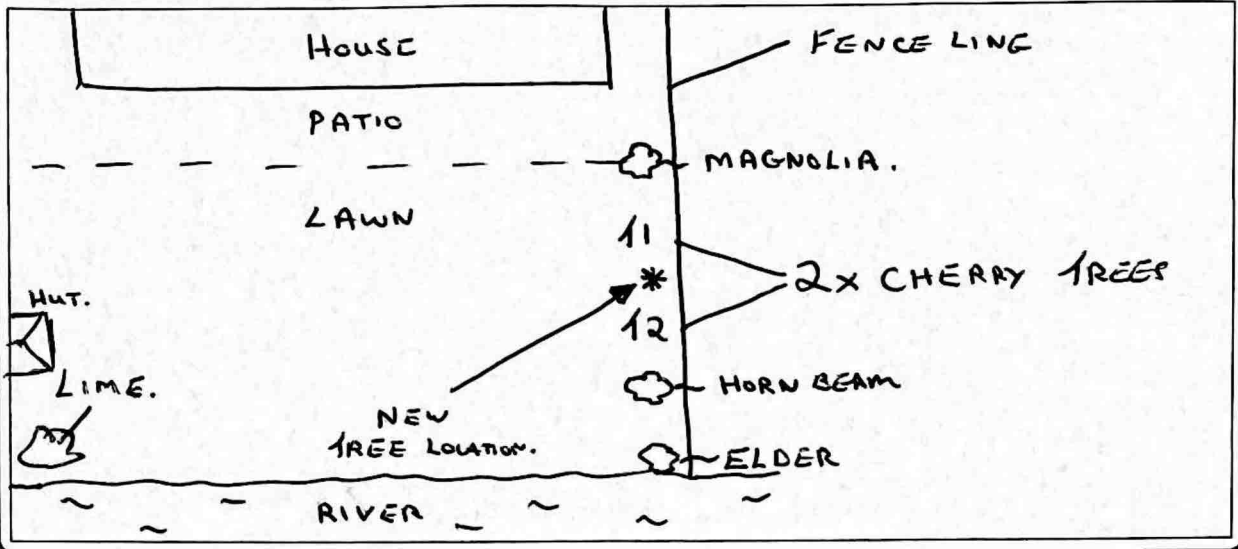
Two 40yr+ old trees are past their prime and are showing signs of fungal infection. proposal is to cut them down, remove stump and replant with single replacement cherry. We have already planted a Horn Beam and Magnolia Grandiflorus in anticipation of the loss of these two old trees.

T1 - Cherry: fell because of age and fungal infection. Replant with 1x Prunus Accolade 2m to Right halfway towards T2.

T2 - Cherry: fell because of age and loss of shape and luster. Hornbeam tree already planted as a replacement 3m towards river.
