The Plan as proposed from Essex Tree Surgery is to "Reduce all round". The tree is currently touching our property at the roof and we have been advised that vermin would be able to use it to access spaces in the loft

 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
