The applicant is advised to have regard to the document "Professional Practice Guidance: Gym Acoustics Guidance, March 2023" and to engage a suitably qualified acoustic consultant to ensure that the requirements of conditions 5, 6 and 7 of this permission will be met. Noise (including vibration) emitted from the building must not cause nuisance to the occupiers of other premises in the vicinity, particularly residential properties, and the Council has powers under the Environmental Protection Act 1990 to serve Noise Abatement Notices, any breach of which can lead to the seizure of noise-making equipment and/or prosecution with significant fines for each offence.
