It has detailed planning permission under Application No. 22/02399/APP for demolition of existing buildings and redevelopment of existing employment site to form a Rural Business and Enterprise Hub (Use Class E) comprising two single storey office/business units, single storey link building, cycle storage, showers and toilets, car parking, internal access road and vehicle turning areas, re-routing of public footpath and associated engineering works including retaining walls, drainage and landscaping. It lies to the north of the B488, to the immediate west of Tring and south of Drayton Beauchamp.
