There are 2 trees within the rear garden of this property which belongs to Ackworth United Charities. Both trees T1 and T2 are sycamore and require crown lift and crown thin and clean

  - showing the approximate distance between the application tree(s) and buildings
  - adding other relevant features on the site (e.g. greenhouse, paths)
