The condition of the existing render to the West facade of the castle is very poor with numerous fissure cracks and unsafe areas of delamination. A large quantity of decorative render has fallen from the facade and there are areas of high discolouration and lichen growth. The proposals seek to remove all the render and to reinstate it on a like for like basis. This work will be done by reusing the exact moulding profiles and dimensions as recorded to reinstate the same render material using the same methods with which it was originally installed. The windows will be overhauled. The proposed render and windows will be redecorated to match the existing colour scheme.
