1. INTRODUCTION

1.1 Introduction

Ethos Environmental Planning (Ethos) have produced this consolidated Landscape and Ecology Management Plan (LEMP) for ecological stewardship of habitats and species at Thatchers Cider Company Ltd at Myrtle Farm, Station Road, Sandford, Somerset.

1.2 Site Location

The Thatchers Estate, is located at the northern end of the village of Sandford, Somerset (central grid reference ST 42091 59651). The site is comprised of orchard plantations, grassland, hedgerows, production warehouses, office facilities.

1.3 Scope

This 'Programme of Ecological Mitigation Works' sets out the ecological mitigation and enhancement measures to maintain, protect and enhance the ecological value of retained and created habitats associated with the Warehouse Extension (phase 2) and new building (Thatched Barn) Condition 14.

20/P/2619/Ful -Warehouse Extension (phase 2) and new building (Thatched barn) Condition 14:

Biodiversity

All ecological mitigation measures identified in the ecological addendum, and the Habitats Regulations Assessment (with the additional enhancement provision of a night roost) together with the measures proposed in the approved plans listed in condition 2 including removal of existing high mounted security lighting shall be implemented according to a programme to be approved by the Local Planning Authority.

Reason: To ensure compliance with the Conservation of Habitats and Species Regulations 2017 (as amended), the Wildlife and Countryside Act 1981 (as amended)], Protection of Badgers Act 1992 and the Wild Mammal Protection Act 1996; North Somerset's Core Strategy policy CS4 and Site and Policies Plan Part 1, Development Management policy DM8. All sites should achieve net ecological gain in accordance with the NPPF, UK Government 25 Year Environment Plan.

This document sets out the timeline for the implementation of the ecological measures covered by the reports associated with the application as listed below:

- Bat Survey Thatchers Warehouse Extension and Meeting Rooms, v3 (Ethos, October 2020).
- Ecological Addendum v1 (Ethos, March 2021).
- Thatchers Warehouse Extension and Meeting Rooms shadow HRA, v2 (Ethos May 21 and NSC).
