Copper Beech. Mature. Fell. Located over a road, telephone and LV electricity lines and within striking range of Chester Hill Lodge. Significant scale basal cavity with subsequent loss of all heart wood and approx 30% cambium loss although well compartmentalised. Loss of tension wood and potential unknown extent of decay in the root plate due to Armillaria spp.. Cavity opening is large and opposite to the weighting in the crown.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
