To remove Two Norwegian Maple trees labelled 3(1) and 3(2) see attached file

3(1) is situated on the route of the water main and sewer pipe and is causing structural damage to the water main. (see photos attached)3(2) trunk is only 108 inches away from the corner of the main house and has already caused structural damage to the nearby garden wall (see attached photos) and overhanging roof so concern is it will cause structural damage to the bungalow in the future.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
