Copper Beech (T1)- We would like to reduce the whole crown by approximately 3 meters in height and spread. The tree is starting to get a bit leggy and big. To retain the tree and stop it growing too big, we would like to reduce it. Currently has a13.9 meter spread and height of 17 meters. After the reduction, will have a spread no smaller than 10.9 meters and no smaller than 14 meters tall.
