Existing single storey classroom building. Sited above ground and constructed using prefabricated, modular type off site components.

Please state the reasons why demolition needs to take place

The building is in active use as a teaching facility but the condition of the building fabric is in a poor condition and offers unsatisfactory internal conditions for teaching. It is poorly insulated and very inefficient in terms of energy demand and retention of heat.

Please describe the proposed method of demolition

Works to be undertake by a specialist demolition contractor. The building is single storey, so small scale mechanical machinery will be used to dismantled and deposited into skips within the construction site compound.

How and where would spoil/rubble be disposed of?

Skip waste would be proceed off-site at a specialist recycling facility, likely to be Pinden in Longfield.

Following the demolition and site clearance of any waste materials the site is to be reutilised for the construction of a new single storey classroom block on approximately the same footprint.
