### Description

Please describe details of the proposed development or works including any change of use

Following detailed design, subsequent to approval of application CA/23/00241, the extent of the alterations are structurally unviable so permission is sought to demolish the pre-existing dwelling to ground level in its entirety and replace with a new dwelling. The design is visually consistent with the previous approval but provides a new dwelling that exceeds current thermal and energy standards with the introduction of PV's, ASHP, MVHR, UFH to both floors, and high performing insulation.

In line with the previous approval, the existing garage is to be demolished and replaced with a new double garage with study to first floor and link porch, along with driveway modifications to improve access and gradient. The previous application included an 'in / out' driveway which is not deliverable due to the location of an electricity pole, so the left hand access has been removed with the existing access increased slightly in size to aid with turning in to the driveway from the highway.

This replacement dwelling would be a 'self build' with the build managed by the applicant.
