T1. Ash. Removal to ground level. As a result of historic poor work, the tree is suffering from extensive heartwood decay and is shedding limbs. We removed the top section of the stem approx 10 month ago after a limb failed (please see attached photo). After removing this we discovered that the stem is completely rotten (again please see photo of last disc cut from top).
You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
