Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

We would like to remove the Eucalyptus tree situated at the front of the house alongside the front wall boundary and to the right hand side of the driveway. The tree was planted by the previous owners of the property as she was Australian, but it is not native and is not in keeping with the conservation area. We are having difficulty growing native plants and shrubs in the area around the tree as it removes much of the moisture out of the soil and leaves the adjacent ground very dry. Although the tree was crowned quite recently its growth is prolific and we would prefer to remove it at this stage having attempted to work around it.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
