T8 on the TPO map, Weeping Ash. T3 on the TPO map. you have down as a walnut but is actually an Ash tree. Crown lift all trees to 2mts for security reasons. You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
