Poplar (T3) - Crown reduction by 2m, with a programme of work repeated a minimum of every 2 years to maintain the height of the tree. The expected canopy growth (shoot extension) of this species is approx. 1m per year. This equates to cyclical pruning after a minimum of two years to maintain an acceptable height for the signal. Initial work designed to clear line of sight between telecoms masts, programme of work designed to maintain height of the tree and line of sight clearance.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - marking all trees on the plan, but only numbering those to which you want to carry out work
  - $\circ~$  showing the approximate distance between the application tree(s) and buildings
  - adding other relevant features on the site (e.g. greenhouse, paths)
