Replacement Planting (TPO only)

If you are proposing to remove a tree covered by a Tree Preservation Order, we will general expect you to provide a replacement tree for each tree removed.

As a minimum replacement trees should at least a 'Standard' tree in accordance with British Standard 8545:2014. The tree should be no less than 8cm in girth and 2.5 meters in height at the time of planting. Sometimes we may require you to plant a larger tree, if we do we will advise you of this as part of processing your application. It is expected that replacement tree planting takes place as soon as possible, please not in column 4 when replacement planting will take place and by who.

NOTE: If you are an agent working on behalf of a client you must seek your client's agreement regarding replacement planting proposals prior to submitting the application and agree who will undertake the planting.

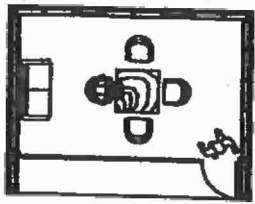

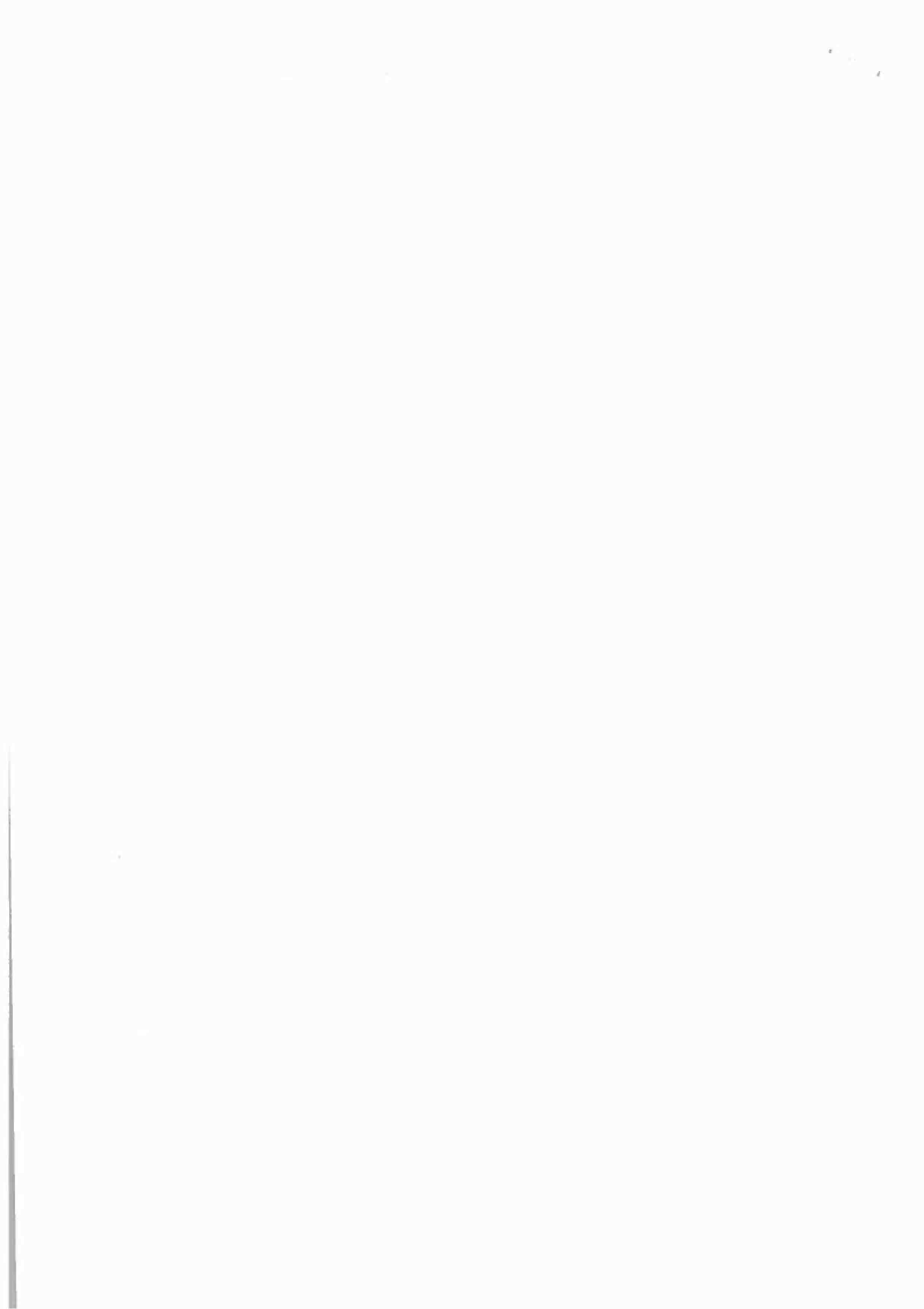
