Silver Birch (T01) – PRUNE: crown reduction by 3.5m to 10m above ground level to reduce wind loading on recently exposed canopy Horse Chestnut (T02) FELL: due to crown dieback & cambium breakdown from unknown root disorders affecting multiple plants within the rear garden

Replant with 1no. Zelkova serrata "Flekova" 8-10cm girth to be located within the rear garden

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - $\circ\;$ showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
