Beech tree. Columnar variety? Remove crown and reduce height to 5m. The tree is currently about 8 - 9 m high.

Reducing the tree height will allow more light into the garden, and will keep the tree from getting too high. It was planted around 25 years ago.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
