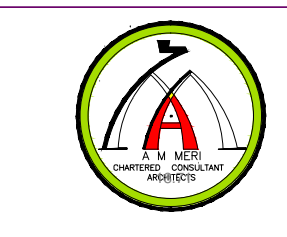
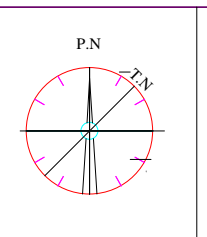


**EXISTING REAR ELEVATION**
