This application concerns a Silver Birch which is to the right hand side of the residential property (looking towards the house). It is now close to the house and attached garage overhanging the same. For safety reasons for both property and persons living within and visiting the property, the intention is to remove the tree if necessary, or alternatively to carry out such reduction in size of the tree to remove it substantially

without affecting the root base should that cause additional problems to foundations or services.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
