VINYL ON CONCRETE

REMOVE : EXISTING SHUTTER CURTAIN, FIT NEW GUIDE RAIL, ANGLE, BOX SECTION AND INSTALL NEW PART PUNCHED/PART SOLID LATH SHUTTER CURTAIN TO SPAN REMAINING WIDTH

REMOVE: EXISTING 3 X GLAZING PANELS AND MID-RAIL FROM ATM LOCATION

INSTALL NEW: BLACK ALUGLAZE PANELS, ATM-ENCLOSURE, ELECTRICS, PLINTH, ATM AND NON-ILLUMINATED DI-BOND SIGN

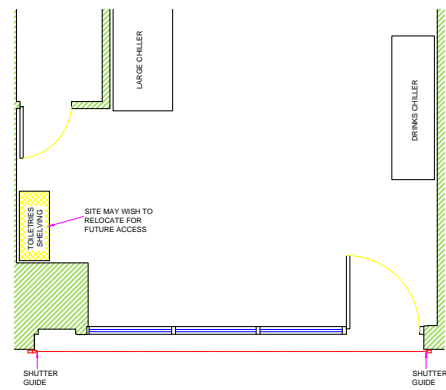

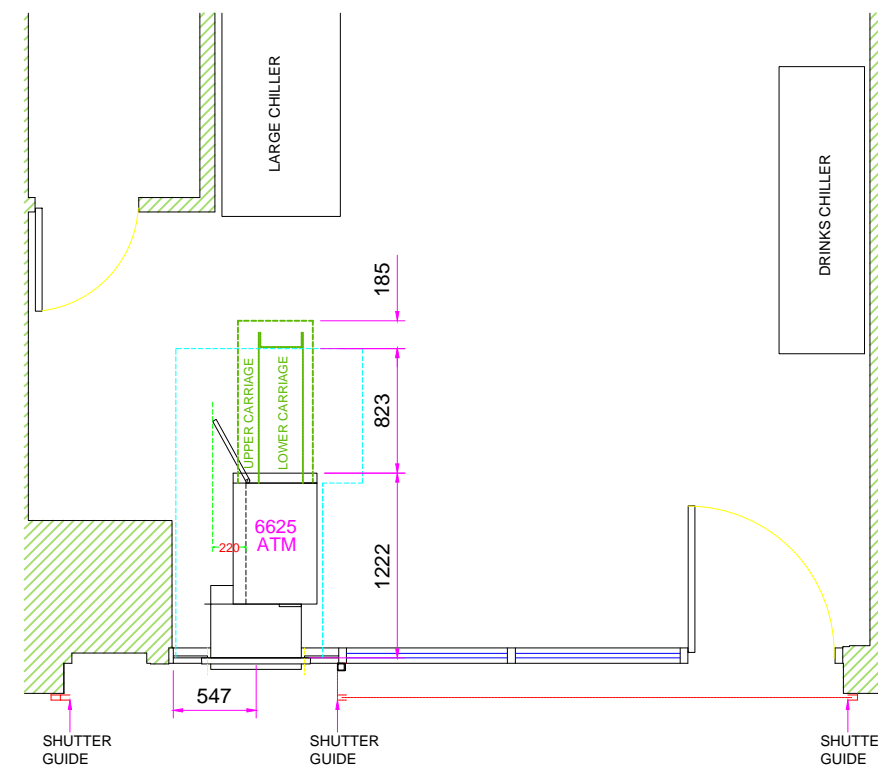

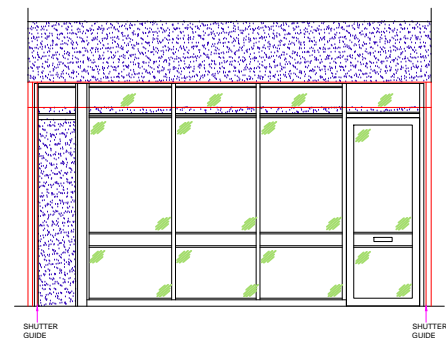

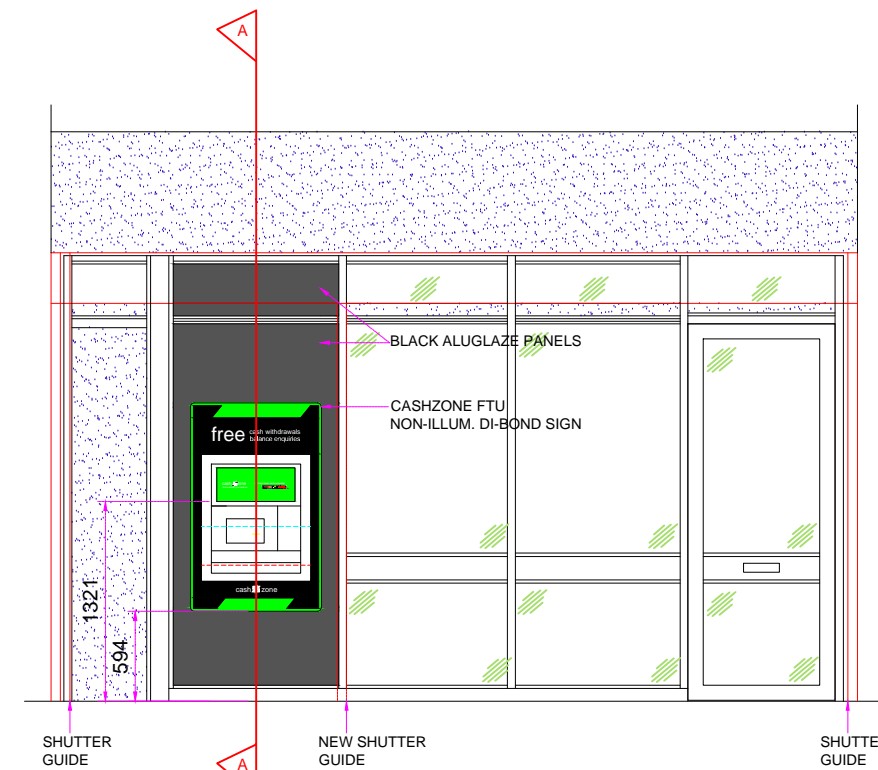
EXISTING (PART) PLAN



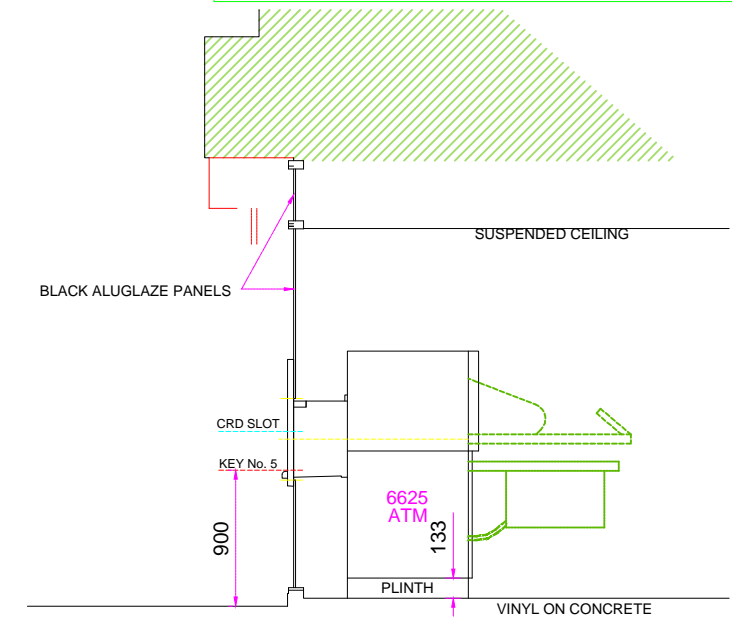
PROPOSED (PART) PLAN



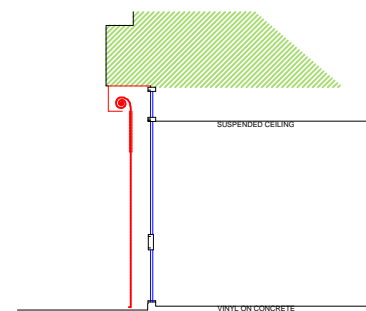
EXISTING ELEVATION



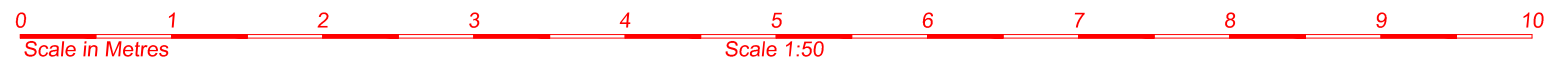
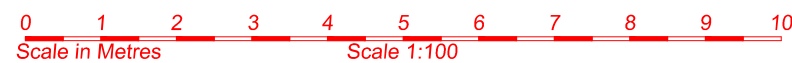
PROPOSED ELEVATION
