Removal of a diseased apple tree, which is producing small misshapen apples which rot on the tree. I planted the tree just under 40 years ago and it fruited well until 2 years ago, when the problem started.
Identification of Tree(s) and Description of Works
Please identify the tree(s) and provide a full and clear specification of the works you want to carry out
Removal of a diseased Bramley apple tree in the back garden. I planted the tree nearly 40 years ago and it produced fruit until 2 years ago. It now produces small mis-shapen fruit that rots on the tree. I plan to replace it, at a different location with another fruit tree, in due course.
You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - o showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
