No work to any trees under TPO.

We wish to simply trim back the annual growth in hollies and bushes where they grow alongside and overhang our rear boundary; maintaining the height and shape of the hollies to around 12-15 foot as in previously approved applications. We are aware of and mindful of tagged trees in the woodland but none are in the immediate vicinity of the pruning required. All cuttings will be removed and as in the past, the work will be contracted to a suitably qualified entity.

There is no impact on users of the woodland or the habitat and fauna within.

This work will be repeated every 1 or 2 years depending on the rate of growth.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
