T1 Oak tree in middle of garden- fell to ground level

The trees health is in decline. It has lost several large limbs. There are no signs of fungal fruiting bodies however there is exposed wood with signs of decay near to the roots. As seen in picture attached, the latest limb to fall shows concerns for the overall health of the tree.

Its proposed that the tree should be felled to ground level on the grounds of health and safety.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
