T3-Cotoneaster

Raise canopy height over entrance drive from neighbouring tree to 2.5m clearance above ground level.

Lightly prune lateral crown spread by 0.5-1m from branch tips to contain spread

T4-Laurel

Fell to ground level

T5-Silver Birch

Fell to ground level to favour the large Walnut behind.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- if there are many trees on the site, make clear which tree(s) are included in this application by:

 - $\circ\;$ showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
