T1)- To attend to the Holly tree located on the right boundary of the front garden.  To reduce the tree down to its previous cutting points (approximately 8ft below the cables running through the tree) and re-shape all round, leaving in its best shape possible.
T2) To ottand to the Charmy tree (oursed by the speighbour) adjacent year Helly tree

T2) - To attend to the Cherry tree (owned by the neighbour) adjacent your Holly tree.

To tidy the side of the tree that overhangs the front garden and fade into the owners side.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
