T1 Home Oak to be reduced by 3m all round (all ides and top) The reason we feel it needs to be cut back as much is due to safety concerns. The tree is double stemmed and has quite a bit of decay in the trunk. It needs to be pruned back to healthy growth points to keep the tree in a manageable and healthy condition for the future.

T2 Cut leaf Lime tree 2 be reduced by 2m all round as tree is over hanging and encroaching on neighbouring property and to keep the tree to a manageable size for its surroundings.

T2 Sycamore tree 2 be reduced by 2m all round as tree is over hanging and encroaching on neighbouring property and to keep the tree to a manageable size for its surroundings.
