## Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

The application is for removal of a Large Monterey pine tree situated on a property boundary between the vicarage and the owners property Trengwydh. The land owner has had a severe problem with the wall being destroyed by the tree as it's starting to lean and uplift, indicating it's imiadaite falling.

This tree if it fell could land the land owners building in close proximity and also completely damage the wall it's grown into. The land owner of the vicarage also has a mini digger and dumper parked underneath which I am unsure he is aware of the trees condition. A severe wind/ storm could force the tree to fall in a 180 degree direction in the way its leaning. As it's grown into a bank it's weaker than a tree growing on a flat surface, and has already indicated which way it will fall. I believe anything in its path could be affected, and would strongly suggest for its removal as soon as possible before destroying any more of the wall or any property. I would class this as a potential emergency as it would be an absolute nightmare to clean up and rectify if it falls prematurely, without careful dismantling and felling. The stump has grown into the wall and if it falls would result in the whole wall being displaced and lifted by the root plate.

Being a fully qualified professional arborist/ tree surgeon I would carefully remove each branch and lower any remaining branches that pose a problem to any property or the wall. The only outcome as it's a Monterey pine would be to remove it to ground level and replant close by, as any pruning would result in the tree being unbalanced and also unsightly as it would not regrow. Replanting with a native suggested tree such as a beech or oak as it would blend in with the natural woodland surrounding the area.

The tree is not currently covered as a TPO and doesn't have a unique TPO number, but I believe it's in or borders the conversation order for the woodland.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

  - mark and name surrounding roads
  - sketch in buildings, including adjoining properties
  - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - marking all trees on the plan, but only numbering those to which you want to carry out work
  - showing the approximate distance between the application tree(s) and buildings
  - adding other relevant features on the site (e.g. greenhouse, paths)
