Work to mature Cypress tree.	
The tree is approximately 10 metres high and sited approximately 4 metres from the back of the house.	
The height of the tree and proximity to the house is a concern as it is now becoming unstable in high winds, we are worried it may fall onto the house (Grade 2 Listed Building) during a storm.	
A tree surgeon has been consulted and has suggested reducing the height of the tree by approximately three metres to give it more stability.	
The tree is marked on the attached plan.
