T1 - Maple - reduce height from approx. 14m to approx. 6m to negate risk to adjacent property. Tree has outgrown its location and currently overhangs the dwelling. Alternative would be to fell and remove due to risk it poses to the property.

T2 - Silver Birch - reduce lateral roadside limbs by approx. 1m

T3 - Birch - reduce crown by 2m (height and sides) to balance if deemed necessary once Maple has been reduced...
