T1 Hornbeam.Fell and Poison stump.Tree is being overshadowed by the other trees and is making it very dark in that corner of garden.

Most of the other trees have alreadt been reduced at some point.

T2 Lime.

Reduce to height of T3 when it has been reduced.

T3 Chestnut.Reduce to previous cuts.

T4 Oak.Reduce to 3ft behind previous cuts.

T5 Hornbeam. Reduce by 30%.

T6 Large Oak.Reduce by 30%.

T7 Lime. Reduce by 30%.

T7/8 Hornbeams. Reduce by 30%.

T10 Cherry.Reduce by 30%

T11 Oak.Reduce by 40%

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
