Trees are located in the rear garden of the house (north of the house). There are 11 trees to be felled and removed. All trees to be removed are Common Ash and have Chalara (Ash die back). House is in a gated community so permission to enter and view trees will need to be sought from owners (Mr Andrew Springett 07523255529, Mrs Veronica Springett 07511233301). Tree to be removed are all marked up with red and white barrier tape wrapped around the stem of each tree.

Replacement trees will be planted, these will be Oak and Acer. Removal of the Ash will thin the wood which is beneficial so replacement trees will be 8 rather than 11.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
