## Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

This application is to fell the yew tree in the grounds of Pheasant Cottage and overhanging Cromwell Cottage. This tree is very close to both properties and is beginning to cause damage by lifting the patio of Cromwell Cottage. As seen on the plan this is also in close proximity to a drain that flows through Cromwell Cottage and on to the Septic Tank and Drainage field. Although there is currently no known damage to the drains or foundations the slabs that are lifting are very close to the drain. It is also worth noting that, in mitigation to the felling, I have already planted 5 new trees (Magnolia, Cherry, Apple, Rowan and Crab Apple) in the garden of Cromwell Cottage since I moved here in 2020. As the tree is in the grounds of Pheasant Cottage this has been discussed with the owner and his carer (Primary Contact) who live at Wiverton Hall Cottage (Opposite) and they are all in agreement with this proposal.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - marking all trees on the plan, but only numbering those to which you want to carry out work
  - showing the approximate distance between the application tree(s) and buildings
  - adding other relevant features on the site (e.g. greenhouse, paths)
