T1 Buddleia - Crown lift by 1.5m to creare unobstructed view for neighbour to enter and exit driveway safely on the to the road. Crown thining to reshape tree following storm damage. Crown reduction by 2.0m to remove branches from garage roof and gutters.		
T2 Apple - Crown reduce by 3.0m to clear branches from telephone cables. Crown Thinning as part of annual fruit tree maintenance to promote healthier crop production during next season.
