This horse chestnut (aesculus hoppocastanum) has been planted in a garden that is way too small for the size of the tree. The tree has become over large for the size of the space, with the branches touching the house roof and gutter. The applicant seeks to carry out a crown lift and thin to reduce the size of the tree by taking off 1 metre all over, thus reshaping the tree and improving its health and longevity while at the same time protecting the property of the owner from possible damage.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
