T1 - Oak - Fell due to close proximity to house, garage and parking. Large branch failure in recent years has raised concerns of future branch failure and has significantly lowered aesthetic value. Options of remedial work to reduce risk of future branch failure and improve aesthetics are very limited. Client happy to replant with native hardwood species in a more suitable location away from the house.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
