Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

The Ash tree is shown on the images.

We need to remove the tree as it has Ash-die-back disease. The tree is clearly showing the disease, and the diagnosis has been has been confirmed by Ben Sherrard of Bowman Arboriculture Ltd on 3rd October 2023. The tree will die and branches are likely to fall off. The tree overhangs a well-trafficked ginnell that runs between School Lane and Main St A58. It will therefore cause a health and safety hazard to pedestrians if it is not removed.

We intend to replace the Ash tree with a British native tree, either a Rowan or Hawthorn.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - $\circ\;$ marking all trees on the plan, but only numbering those to which you want to carry out work
 - $\circ\;$ showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
