Tree A. This tree is a Wild Cherry, the crown of which is progressively growing larger on, and beyond, our property boundary. The branches of this tree often break away in medium to strong winds creating a danger to anything or anyone below. I would like to pollard this tree to improve the shape and condition by removing the weakened growth. Tree B. This is a Sycamore which has grown on our boundary and now projects over the adjoining property. I would like to pollard this tree to

Tree C. This is a Weeping Willow that grown in our property reducing the available light to beds and grass. I would like to reduce the crown of this tree by 33%.
