Yew tree 01, as shown in the attached sketch.

Branches need to be trimmed so that they are 1m from the thatch of The Cottage at their closest point, apart from where this takes it close than 50cm from the trunk of the tree. This is minimal work on the tree, and has been completed with permission several times in the past.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
