Tree marked in attached plan. A flowering cherry tree. It is a condition of planning consent DM/21/01273/FPA to seek approval to the removal of any trees. The removal of the tree will facilitate the new access. This process is being used as recommended by Olivia Lamb. In respect of root protection during construction works, the black locust tree will have its roots protected to the extent of its canopy.
